Disclosure Regarding Academic Curriculum Requirements for Licensure

Doctor of Dental Medicine

Federal regulations require ATSU to disclose to prospective and enrolled students whether a program leading to professional licensure or certification meets the educational requirements in each state and U.S. territory. Dentistry is a licensed profession in all 50 states and U.S. territories. To become licensed to practice as a doctor of dental medicine (DMD), a student must graduate from a program accredited by the Commission on Dental Accreditation (CODA) and pass the national certification examination for the Integrated National Board Dental Examination (INBDE) administered by the Joint Commission on National Dental Examinations (JCNDE). ATSU's DMD degree program is accredited by CODA. This curriculum is designed to meet educational requirements for initial licensure to practice as a dentist in every state and most U.S. territories.

State requirements for licensure are subject to change. These statements and program completion do not guarantee licensure. ATSU cannot provide verification of an individual's ability to meet licensure requirements unrelated to its educational program. Students are encouraged to review licensure requirements (including noneducational requirements such as certification/examination work experience, background checks, etc.) for the states in which they intend to seek licensure.
